RESOLUTION TO SCHEDULE A PUBLIC HEARING REGARDING THE VILLAGE OF UNION SPRINGS
INTENT TO APPLY FOR COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FUNDING THE
WASTEWATER TREATMENT PROJECT

WHEREAS the Village of Union Springs intends to submit an application to the New York State Office of
Homes and Community Renewal for funding under the Community Development Block Grant (CDBG)
Program for the 2026 program year; and

WHEREAS, the State of New York has announced that up to \$29.2 million is available through the 2026 CDBG
Program, with up to \$25 million specifically available for public infrastructure projects; and

WHEREAS the Village of Union Springs is considering submitting an application for up to \$2 million in CDBG
funds to support the Wastewater Treatment Infrastructure and

WHEREAS, as part of the application process, the Village of Union Springs must hold a public hearing to
gather input from citizens, public agencies, and other stakeholders on the proposed CDBG application,
community needs, and CDBG funding priorities.

NOW, THEREFORE, BE IT RESOLVED, that the Village of Union Springs Board hereby schedules a public
hearing to be held on July 21, 2026, 6 p.m. at the regular Village Board meeting to receive public comments on
the Village's proposed CDBG application for the Wastewater treatment Project and

BE IT FURTHER RESOLVED THAT the Village Clerk is directed to publish notice of said public hearing in
accordance with applicable laws and regulations.
